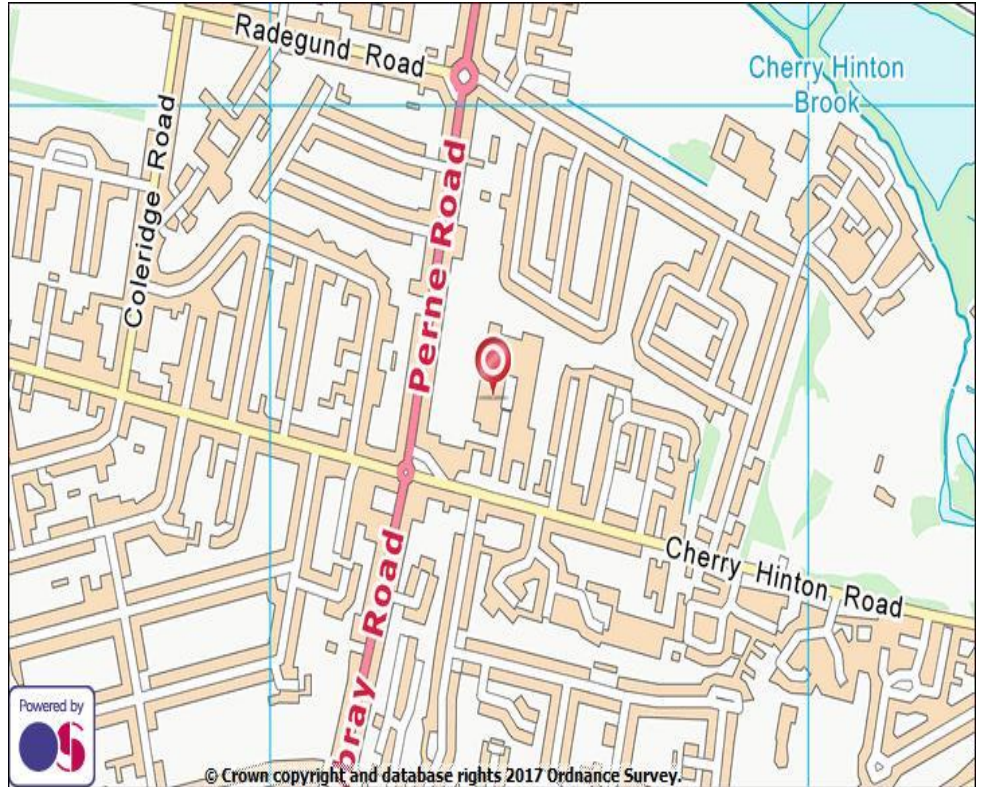
Description

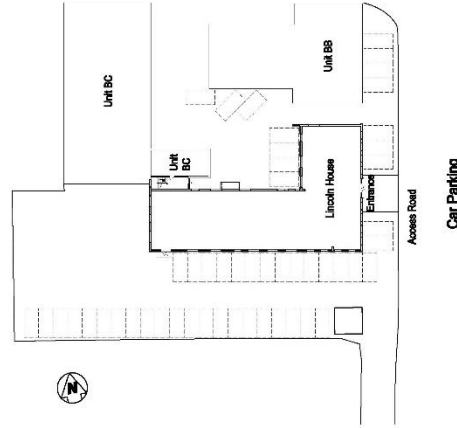
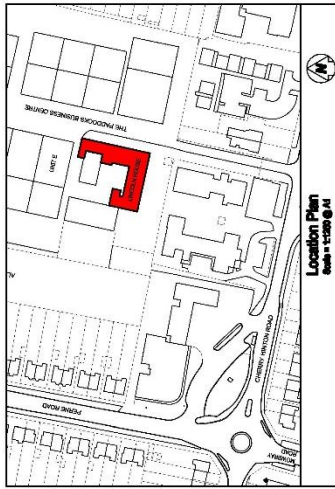

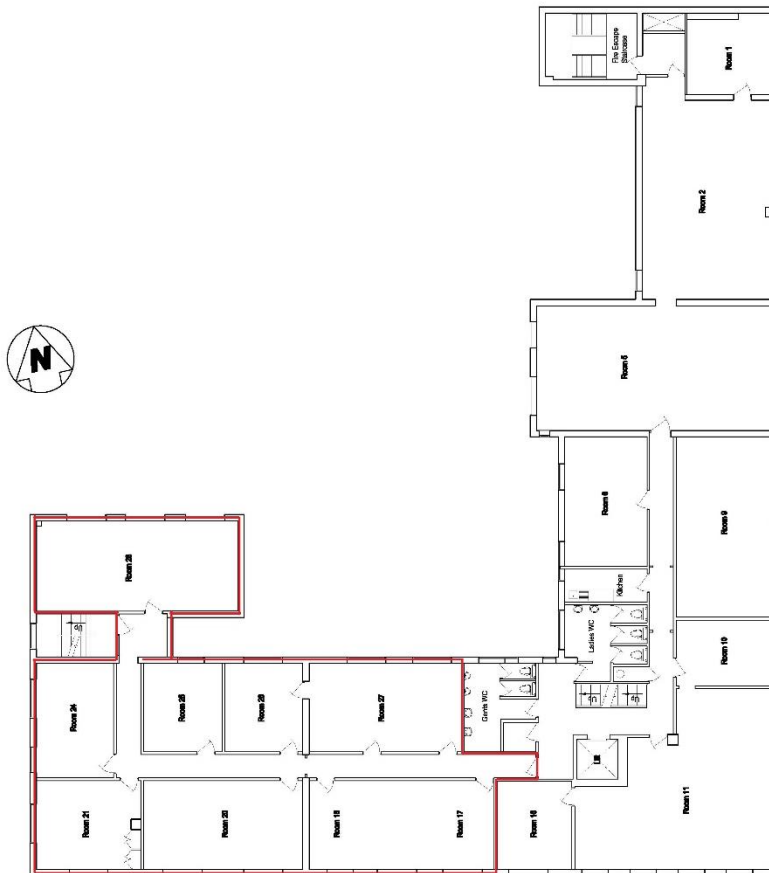
