### Location

The Spicers site is located just off the Sawston by-pass approximately 5 miles south of Cambridge. The property is well located being 2 miles from the M11 motorway providing good connections into London, the South East, the A14 (west) and the Midlands. The A11 is also 2 miles away providing quick access to the A14 (east) and the East Coast ports.

There are railway stations at Whittlesford and Great Shelford which are both 2 miles away and are connected to the Cambridge/London Liverpool Street line.

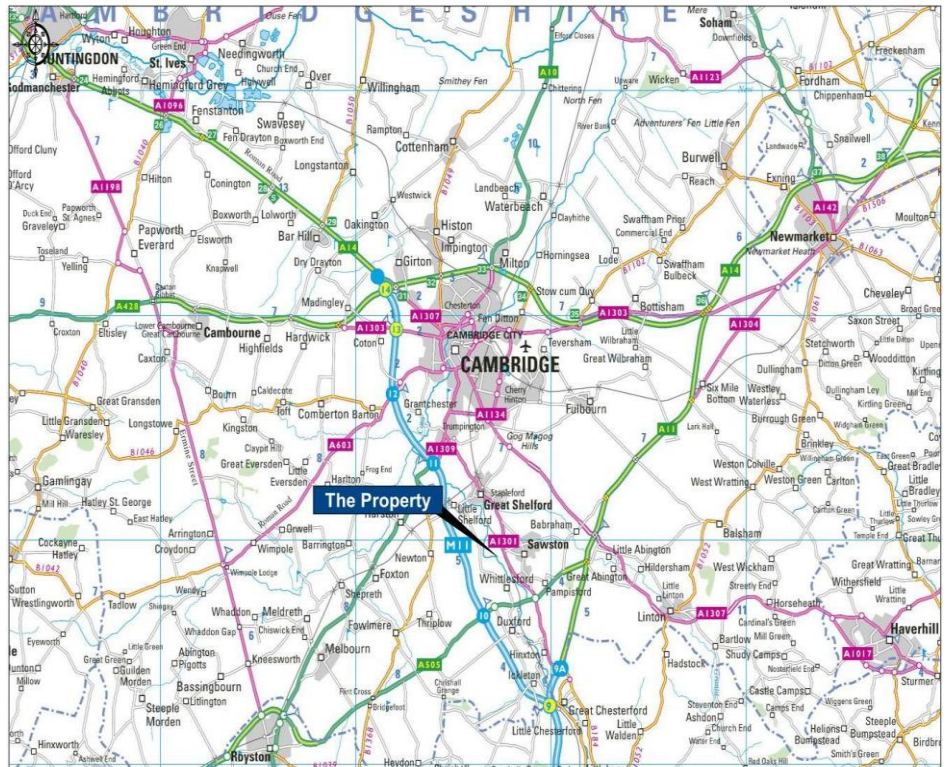
### Description

The property comprises a 5 bay warehouse building with 2 storey offices.

The 5 bay warehouse benefits from eaves ranging from 8.5m to 12m. There are 26 dock loading level doors and 5 surface level loading doors which have all been fully serviced. The unit is lit and heated.
