Dukes Court is situated off Newmarket Road in a prime office location adjacent to the Grafton Shopping Centre.

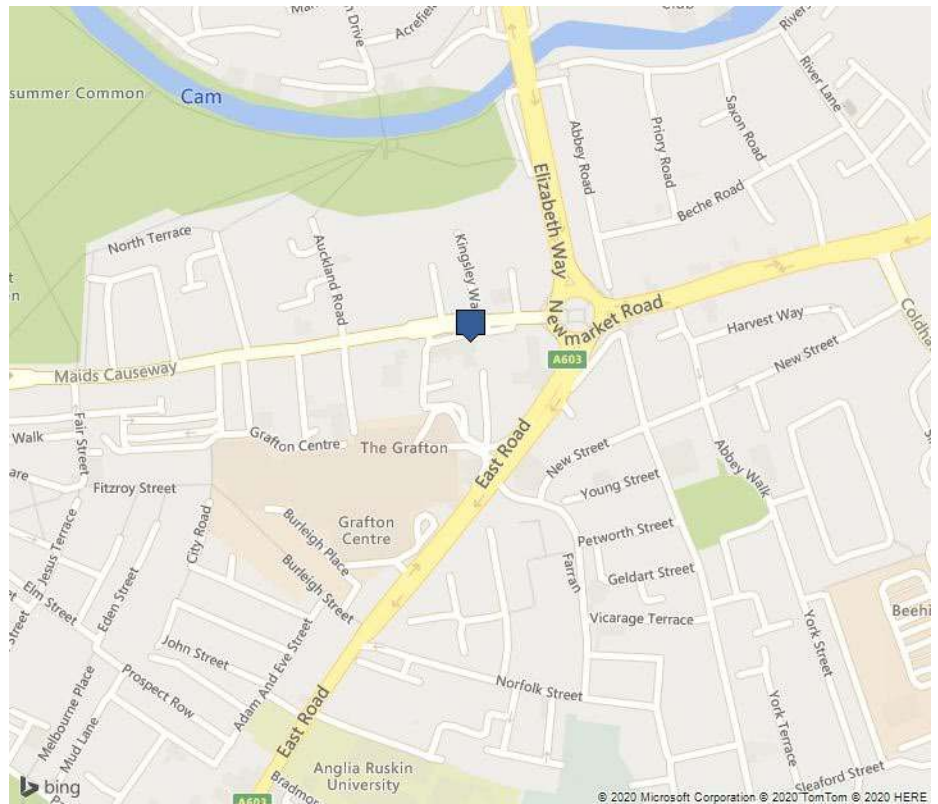
