

## LOCATION

The property is located approximately 2 miles east of the City Centre in an established business area. The A14 dual carriageway is around 3 miles away, via the A1303, while the M11 junction 11 is approximately 4 miles to the southwest.

The property is located just to the South of Cambridge City Airport and the Marshall's development site Cambridge East boasting 900 acres of mixed-use development with the potential to deliver up to 12,000 new homes in Cambridge by 2030.

Cambridge Train Station is located just 2 miles to the west of this property providing good links to London (48 minutes to London Kings Cross) and other National Rail services.
